Feeding Hawaii Together (FHT) reopened its doors to clients on April 1, 2020 after completing renovations to bring the facility up to building code standards. In 2020, FHT distributed almost 1.5 million pounds of food to over 78,000 individuals. FHT built new partnerships with local growers, organizations, and food providers. FHT expanded its Board of Directors, created subcommittees, and recruited new volunteers to be trained to support distributions. FHT purchased a new truck, shelving, forklift, and electric pallet jack to support increased demand due to the COVID-19 pandemic. FHT hired contracted workers to support the increased demand for services and looks to hire additional staff in the upcoming year.
